The data used in this paper are confidential. This file provides some basis information about the datasets that were used.

The datasets contain information on WorkFirst, the welfare-to-work strategy of the State of Washington. Washington initiated the WorkFirst program in August 1997 to help low income families become self-sufficient by providing job placement services, counseling, training, and support services for welfare recipients. We first briefly describe the WorkFirst program and then describe our data.

1. The WorkFirst Program

The WorkFirst program serves three groups of people:

- (a) Parents and children age sixteen or older who receive cash assistance under the temporary assistance for needy families (TANF), general assistance for pregnant women (GA-S) or state family assistance (SFA) programs; and
- (b) Parents who no longer receive cash assistance and need some continuing support to remain self-sufficient; and
- (c) Low income parents who support their family without applying for or relying on cash assistance.

The main service of WorkFirst is Job Search Assistance. Job Search Assistance may include one or more of the following forms:

- (i) Classroom instruction;
- (ii) Structured job search that helps to find job openings, complete applications, practice interviews and apply other skills and abilities with a job search specialist or a group of fellow job-seekers; and/or
- (iii) Preemployment training;
- (iv) High-wage/high-demand training.

When clients first enter WorkFirst, they will work together with case managers to develop Individual Responsibility Plan (IRP). As the initial focus is to assist them in finding employment, they will be first introduced to job search. Periods of job search services may last up to twelve continuous weeks.

2. The Datasets

The data can be divided into two parts: (1) Characteristics of the individuals that apply for the WorkFirst program; (2) participation situation of the individuals.

There are 119539 persons with multiple observations with records from several data sets, with details given at the table below. Explanatory variables are obtained through combining these files.
